Universal Credit- Surplus Earnings Level	Extend the £2,500 surplus earnings level within Universal Credit (UC) in Great Britain until March 2024. Mainly affects the self employed.	4.20

Universal Credit- Uprating the Transitional Severe Disability Premium rates	Increase the Transitional Severe Disability Premium Element rates in UC for 2023-24 by CPI and annually until 2027-28. (previously the element has not been uprated).	4.22
